Re: Discontinuation of paint and coating removal products containing methylene chloride

Dear Valued Customer:

The purpose of this letter is to reiterate our commitment to the discontinuation of sales and distribution of consumer paint and coating removal products containing methylene chloride (the "Products") and to remind you of certain regulatory obligations that take effect later this year. Effective August 9, 2019, Sprayon, Duplicolor, VHT has ceased the manufacture and distribution of these Products in the United States. This action is the result of the U.S. Environmental Protection Agency's (EPA) final rule banning the distribution and sale of paint and coating removal products containing methylene chloride for consumer use.¹ A list of discontinued Products is attached.

We feel it bears repeating that the EPA's final rule expressly prohibits the manufacturing, processing, and distribution in commerce of methylene chloride for paint and coating removal for all consumer uses after November 22, 2019. Thus, any sale or distribution of Products for consumer use <u>must end on or before November 22, 2019</u>. We encourage you to review the final rule, which also includes certain recordkeeping and notification requirements already in effect, to determine how the rule may impact you.

We are continually developing alternative paint and coating removal products, formulated without methylene chloride, that are available for purchase. Please feel free to reach out to your Sprayon sales representative for more information about these products.
